Directions: From the east, take Oakland Park Blvd. to just west of Nob Hill Rd. Turn left after Safety Complex. From the south, take Nob Hill north to Oakland Park Blvd. Turn left on Oakland Park, and left again after the Safety Complex

Date & Time: **SEPTEMBER 10, 2016**
Session 1-Timed Finals - Warm-up 8:00am. Meet starts at 9:00am
Session 2- Begins 10 minutes after session 1 is finished. Warm up and warm down pool is available during session 1.

SEPTEMBER 11, 2016
Session 3 - Timed Finals - Warm-up 8:00am. Meet starts at 9:00am
Session 4 - Begins 10 minutes after session 3 is finished. Warm up and warm down pool is available during session 3.

Pool/Timing: Competition is in the Sunrise Civic Center Pool 50 meters x 25 yards heated outdoor pool. 8 short-course racing lanes will be used. Separate warm-up and warm down lanes will be available. Daktronics Timing System® will be used. The competition course has been certified in accordance with 104.2.2 (C). Water depth at the start is at least 4'6" in accordance with 202.3.7 (C).

Rules: 2016 USA Swimming and FGC rules will govern this meet. Safety rules as outlined by USA Swimming and as recommended by the referee, will be in effect. All sessions are timed finals for all swimmers.

Eligibility: Open to all current 2016 USA swimming registered athletes and foreign athletes with proper travel credentials who have been invited by USA Swimming. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement - USA Swimming Rule 202.3.3

The Meet Host **Will Not** be accepting new or Renewing USA Swimming registrations at the meet. All USA Registrations must be done prior to the start of the competition.

There are no Qualifying Times. **(Meet Entry limit is 400 swimmers and/or to comply with the 4-hour rule.)**

Camera Free: The Florida Gold Coast Swimming **CAMERA FREE ZONE** policy is in effect at this meet. No person may use a camera or any other device capable of recording still or video images in the area behind the starting blocks, in the locker rooms, changing areas, showers or restrooms. Violators may be reported to law enforcement or other governmental authorities and/or may be barred from the facility during the sanctioned event.

Disability Athletes: All swimmers are welcome at this meet. Any athlete with a disability will be accommodated. Please contact the pool office ahead of time to allow for preparations – coachsun1@aol.com

Entry Deadline: All entries must be received by **Wednesday, August 31, 2016 @ 6pm EST.**
Meet Entry limit is 400 swimmers and/or to comply with the 4-hour rule.

Entry Limit/Procedure: Three events per session. The 400 IM, 500 free and 1650 free are positive check in events. Deadline for positive check-in is 10am. These events will be seeded fastest to slowest, and alternating girls and boys. They will be swum as open, but scored separately. 1650 swimmers must provide their own timers and counters.

Corrupted, unreadable or incorrectly formatted files must be corrected within 24 hours of entry deadline. Errors in entries submitted electronically are the responsibility of the applicant. Electronic mail confirmation will be sent within 48 hours after receipt of file.

Confirmation for electronic entries will be sent via e-mail.

**Submission of electronic entries signifies that all swimmers are USA registered. Questions, please contact office at (954) 747-4635

NOTE: Swimmers without registration numbers or birth dates will not be entered. * Entry Fees will be Double if not entered electronically.**

Deck Entries: THE FGC DECK SEED POLICY WILL BE IN EFFECT. Deck entries permitted into open lanes only on a first-come-first-serve basis. **COACHES ONLY, PLEASE.** Deadline for deck entries is 30 min. before start of meet. Policy can be seen at www.fgcswim.org. All deck entered swimmers must be current USA Swimming members in order to be entered.

Fees are **DOUBLE** the entry fee:
\$6.50 per individual event,
\$10 swimmer surcharge.
Cash only for deck seeds.

- Refunds:** Once a team or individual entry has been received and processed, there will be no refunds in full or in part.
- Seeding:** Eligible entries shall be seeded **Short Course yards only**
- Awards:** All events will be seeded as open, but scored separately.
